Denise Blanchette did a presentation over zoom about invasive milfoil danger in Flagstaff Lake. She talked about how prevention is much cheaper and easier to do than to have to remove an invasive milfoil from our lake. Grants are available from the State to help with courtesy boat inspections at the boat launch. The town will make up flyers to put up showing what plats to look for and what to do if you find them. Email milfoil@maine.gov with a picture of the plant and if possible, keep the plant in a something with some water so they can identify the milfoil if the picture was not good enough. Marcia Higgins did some work with milfoil inspections possibly in Rangeley so we can reach out to her for help and information.

Tom Bufalino and Christine Gregor got the liquor license signed by the Selectmen for the Stratton Plaza.

Mike Hewett has asked for a raise. He was making \$14.00 an hour now. Jed made a motion to give Mike Hewett a raise to \$18.00 an hour. Steve 2nd Steve, Jed, Jeff, and Brandi all in favor.
