Selectmen's Meeting
September 7, 2021

Steve opened the meeting and welcomed every one attending.

Jed made a motion to accept the minutes from the meeting on August 24, 2021, Steve 2nd, Brandi, Amanda, Jed & Steve in Favor.

Jeff Lecander joined the meeting

Looney Moose asked for their liquor license to be sign for another year. The town had no complaints about the Looney Moose and Signed the Liquor license application.

Kenny Wing spoke about Arlene Knowles wanting to be buried in The Alva & June Knowles Plot.

Steve moved that the board go into executive session pursuant to 1 M.S.R.A. § 405(6)(a) to discuss to pay employees while out on medical leave.

The meeting then continued after the executive session.

Jed made a motion to pay an employee out with Covid-19 if there was Health Care Act Dollars available, if not the employee would have to use either sick time, vacation time or go unpaid, Steve 2nd, Amanda, Brandi, Jeff, Jed, Steve in favor
